

WASTEWATER OPERATOR CERTIFICATION EXAMINATION SCHEDULE

January 1, 2010 - December 31, 2010

This form will assist in determining the date and location of the certification examination you wish to schedule for. Individuals must complete and submit the appropriate wastewater operator certification application for the examination they wish to take. Only individuals who have previously been approved for an examination or have previously failed an examination may reschedule for the same examination either by telephone or by completing and submitting the form at the bottom of this page. To insure proper processing, it is important that all of the requested information on the form submitted is completed accurately.

A COMPLETED APPLICATION MUST BE SUBMITTED IF YOU ARE A FIRST TIME APPLICANT OR IF YOU WISH TO TAKE THE EXAMINATION FOR A HIGHER LEVEL WASTEWATER CERTIFICATE.

To allow sufficient time for processing, applications and rescheduling forms must be received by the Operator Certification Unit at least 2 weeks prior to the desired examination date.
